# We're motivated by a desire to help Oregonians and improve the state's economy.

The people of Oregon saw an urgent need to protect both workers and businesses when, in 1914, they created SAIF through an act of the state legislature. We became a selfsupporting, not-for-profit public corporation in 1980.

Since the major reforms of 1990, Oregon's workers' comp system has become one of the most successful in the nation, with low costs for employers, improved workplace safety, and innovative return-to-work programs. By focusing on safety and implementing other reforms, claims per 100 workers are down 68% and premium rates have dropped more than 84%.

From day one we've been a mission-driven company, looking to improve the state's workers' compensation system by setting the industry standard for affordability, availability, innovation, efficiency, and service quality.

Today, our vision is to make Oregon the safest and healthiest place to work. And by protecting workers and employers, we strengthen Oregon's economy.

# **SAIF** services

### **Claim management**

We don't just process claims—we manage them. Our claims adjusters, vocational specialists, return-to-work specialists, nurse consultants, and legal staff work together closely to contain claim costs and help injured workers get back to work.

- In 2023, our trained return-to-work consultants were able to help 88% of workers with disabling claims get back to work within the first 60 days of time loss.
- We make compensability decisions in half the time allowed by law, and in 2023 only 1.3% of our claim denials were reversed.


- Our claims adjusters specialize in reviewing permanent total disability (PTD) awards.
- We audited more than 510,000 medical bills in 2023, saving policyholders \$175.8 million by identifying inappropriate medical procedures, improper billings, and violations of workers' compensation rules pertaining to reimbursements.
- Our contracts with Oregon's leading managed care organizations (MCOs) assure the highest quality medical care for injured workers, while delivering discounts on everything from surgical procedures to prescription drugs.
- Our attorneys work in partnership with claim professionals, and communicate regularly with policyholders. Requests for hearings have been reduced significantly.
